## Cysurance Certification Warranty Conditions

- MFA on all email accounts
- Back-ups that are scanned for viruses
- PHI/PII encryption (if regulatory conditions apply)
- Data privacy compliance (if regulatory conditions apply )
- Patch updates within 60 days of release
- Out -of cycle invoice and wire validation documented
- All events verified through log data

## Program Pricing

Participants with annual revenues under \$100M can access flat-fee cyber insurance plans ranging from \$1M to \$5M coverage limits. For those with revenues over \$100M or needing higher coverage limits, alternative pricing options are available. Contact Cysurance for more information.
